



## 2017 SCHOLARSHIP AWARD NOTICE

Council for Working Women (CWW) of the Joliet Region Chamber of Commerce and Industry has scholarships available for 2017. The Council for Working Women established the scholarship fund to assist **working or recently unemployed women** who are training to: re-enter the workforce; increase skills for employment; or begin a new career. The scholarship money will help recipients further their post-secondary education at local vocational/trade schools, accredited colleges or universities.

The Scholarship Fund is supported by fundraising and contributions from members of the Council for Working Woman. The application deadline is June 16, 2017. Scholarship recipients will be notified by July 10, 2017. Scholarship funds will be applied to the upcoming semester for the 2017-2018 academic year (classes must begin after July 1). Scholarship funds may be applied to tuition, books, or fees and will be mailed directly to your educational institution. Scholarships will range from \$1,000 - \$2,000.

### **ELIGIBILITY REQUIREMENTS:**

- Applicant must be female, be a U.S. citizen, be a high school graduate or have her GED.
- Applicant must live, work, or attend school in Will County.
- Applicant must be currently employed or re-entering the workforce.
- Applicants must have a total of two letters of recommendation. Each letter must be from two different categories choosing from the following list: instructor, employer, community service professional, a member of the CWW, or any other member of the Joliet Region Chamber of Commerce.
- Applicant must be registered in an accredited post-secondary educational program in a vocational/trade school, college or university.
- Prior applicants and award recipients are eligible to re-apply.

### **APPLICATIONS MUST BE COMPLETE TO BE CONSIDERED.**

- Two (2) letters of recommendation. Each letter must be from two different categories choosing from the following list: instructor, employer, community service professional, a member of the CWW, or any other member of the Joliet Region Chamber of Commerce.
- Unofficial transcripts from all colleges and/or institutions attended to date. (*if applicable*)
